Paper Format. Consistency in the order, structure, and format of a paper allows readers to focus on a paper's content rather than its presentation. To format a paper in APA Style, writers can typically use the default settings and automatic formatting tools of their word-processing program or make only minor adjustments. The guidelines for paper format apply to both student assignments and manuscripts being submitted for publication to a journal.

Set the basic layout parameters. An APA style paper should use a 12 point font size and be double spaced throughout. One inch margins all around are also recommended. Use this basic layout on every page of your paper.

Such notations are called in-text citations, and APA format dictates that when citing in APA format in the text of your paper, use the author's name followed by the date of publication. For example, if you were to cite Sigmund Freud's book The Interpretation of Dreams, you would use the following format: (Freud, 1900).

### APA Format: Basic Rules You Must Follow

Place manuscript page headers one-half inch from the top. Put five spaces between the page header and the page number. Full title, authors, and school name are centered on the page, typed in uppercase and lowercase. 34

General Chicago Manual of Style Guidelines for Formatting Your Research Paper. Double-space between each line of type on the page. Double-space between all lines of the paper. Only use single-spacing or one-and-a-half spacing for block quotes. Leave uniform margins of at least 1 inch (2.54 cm.) at the top, bottom, left and right of every page.

Insert page numbers justified to the right-hand side of the APA format paper (do not put p. or pg. in front of the page numbers). For all pages of the paper, including the APA format title page, include the "TITLE OF YOUR PAPER" justified to the left in capital letters (i.e., the running head).
